Healthcare has become one of India's largest economic sectors – both in terms of revenue and employment. India, land full of opportunities for medical companies to explore and expand their business horizons in the ever booming Indian healthcare market.

Indian healthcare sector is growing at a 15 % CAGR to reach US\$ 158.2 billion by 2017. Imports of medical devices and equipment in India is likely to cross US\$ 4 billion mark by 2018–19 from a level of about US\$ 2.3 billion as of 2013–14.

The overall inflow of foreign investment in hospital and diagnostic sector was more than US\$ 1 billion during last decade and the overall FDI inflow of medical and surgical appliances is expected to be more than US\$ 22 million in the next couple of years.

### INDIAN GOVERNMENT INITIATIVES TO BOOST HEALTHCARE SECTOR

- Global Investment Hotspot: 100% Foreign Direct Investment is allowed for health related services under Automatic route.
- Encouraging Tax Regime: Foreign investors can avail an income tax exemption of 5 y ears on hospitals located in Tier II, Tier III cities and rural areas.
- Lower tariff is levied and higher depreciation is charged by government on all the medical and health care equipment.
- Boost in healthcare facilities: National Rural Health Mission has sanctioned more than US\$ 10 billion for capacity enhancement and up gradation of healthcare facilities.
- India's first medical devices industrial park is set to come up in Gujarat and the second one is being planned for Tamil Nadu.

# OPPORTUNITIES IN HEALTHCARE

- Additional 1.8 million beds needed for India to achieve the target of 2 beds per 1,000 people by 2025
- Additional 1.54 million doctors required to meet the growing demand for healthcare
- Estimated Investment to the tune of over US\$ 86 billion may be required to meet the healthcare demand.
- Over US\$ 200 billion is expected to be spent on medical infrastructure by 2024.
- Inflow of medical tourists is expected to cross 6 million by 2018.
